HONORARY SUB-BRANCH SECRETARY REPORT



Hello Members,

I will commence this report by thanking all of the sub-Branch members for their continuing support while the Club was closed from March 2020 until it re-opened in September 2024. Whilst the Club is no longer an RSL Club, it is still the home of our sub-Branch and will be for many years to come.

This is a result of the Deed of Accommodation Agreement your Committee and Trustees negotiated when we sold our part of the property to the Club. The sub-Branch now has two offices and a meeting area on the first floor of the Club open to all sub-Branch members when the office is attended.

We held our first meeting on our return to the Club in the Club Function Rooms on 22nd September, followed up by your Christmas Quarterly meeting on the 15th December 2024. Currently we have 96 Service members and 34 Affiliate members registered, but unfortunately we are still not having many of them attending these most important meetings. It is important we have members attend as at times some important decisions need to be endorsed by our members.

An example of this is at our December meeting the members in attendance were asked to consider the sale of the holiday property at Patonga. As your Secretary and also your Property Manager for over 25 years, I indicated members and guests are not using the holiday units and they are not returning sufficient funds to be a viable investment. I quoted the following examples of income and expenditure:

This indicates for example, in 2024 the income averaged just under \$400 per month. The properties were valued conservatively some time ago at \$2 million minimum and to invest that sum of money at only 1% we would get a return of \$20,000 a year. Simple economics and currently we are receiving interest of over 4% from the Military Bank which would return about \$80,000 a year. The question put to the members was to gain approval for the Trustees and the Committee to enter the first stage of obtaining approval to sell the property. This was approved by the Service members with three against. The Trustees will now

move towards the next step in selling this property which I have indicated had negative income in 2024. the property comprises two town houses, under the one title, constructed about 1994. It is now requiring continuing maintenance and the replacement of furniture and white goods. If sold a substantial capital gain will be achieved to either purchase another property or invest the income. Our current returns on our investments with Morgans Stanley (\$3M) Ethinvest (2.5M) are returning over 8% per annum with the other investments with the Military Bank also returning over 4.5%.

I also carried out two inspections of our three properties at Laurieton during the year, meeting with the Manager Simon Hancox and discussing any maintenance or general matters requiring attention. At the same time carrying out inspections of the properties with the staff responsible for their management. We also have the property at 2/50 Bondi Road which was recently renovated and leased and is being managed by Richardson and Wrench. All of these properties are providing reasonable returns.

I attended Congress this year as your delegate which was again over 3 days at the Convention Centre in the Wests Leagues Club, Newcastle, which I have reported on later in this report.

Our sub-Branch continues to welcome new members, mostly Navy or ex-Navy, due to the efforts of Troy Nicol, who is one of our Delegates to the Eastern Metropolitan District Council, (replacing me after 27 years of attendance) and he is the Council representative for the NSW RSL State Branch "Sport and Recreation" activities which is directed towards increasing awareness of the RSL. Troy is also involved with Jeanette Kearney and myself in trying to organise activities within our own sub-Branch, one of which is the monthly cake and coffee day held at Club Bondi Junction and Leaf café while other sporting activities are under consideration.

There is a requirement that as a charity and not paying any form of taxation, sub-Branches are required to donate almost all our surplus fund each year to the Veterans Support Fund. The fund was established to allow sub-Branches to elect to donate to certain initiatives within the fund provided they met the aims of the charitable purpose of the State Branch. Some examples are the President's Shield, the Support and Assistance Fund, Lifecare, the Kokoda Track Memorial Walkway. Each of these funds have specific donation amounts so any surplus is directed to other funds. An example is the annual allowance for the KTMW, which we have been donating to for many years, has a maximum allowance of only \$200,000. The members agreed several years ago to donate a minimum of \$150,000 to State Branch each year, provided we have sufficient funds available to meet this agreed obligation. To date we have been able to meet this obligation. If you require any further information regarding the Veterans Support Fund it is available on the RSL Website. As the VSF is the only recognised charity we are now able to donate to, it prevents us from donating to local organisation requiring support, (EG; our previous swimming and sporting clubs etc) or such organisations we have donated to over many years, such as the Cancer and Prostate Councils and other charities which service and care for veterans and their families.

Some of our members have raised the question of the Club no longer reciting the "Ode to Remembrance" each evening at 6pm as was done in the past. It was a Board decision made several years before the Club opened for the Club to become more of a Community Club to encourage more member to join, being mainly younger members. (I recall several years ago I did an analysis of the ages of our members and like the RSL the age average was over 60). This was a majority decision of the Board, not unanimous. The sub-Branch Committee requested the Board to re-visit its decision and the Board agreed to have the Ode presented to members at 6PM each Friday evening. While it is currently being recited by a manager or a sub-Branch Committee Service Member, it is anticipated we will soon have it presented in a professional manner through one of the many Television screens preferably one at the western end of the ground floor area where we may also be able to have our torch symbol. We are also hopeful the Board and Club Management will have photos and names of the Board and the Sub-Branch Committee along with a photo of the King in the foyer of the Club.

This is my 28th year as either your Honorary Secretary or for a short period from 2017 to 2024 as your President, there being no elections this year I intend to continue looking after our great sub-Branch and its members until the election in March, 2026. In mid-2024, I stood down as your delegate to the Eastern Metropolitan Council after serving as your delegate since 1998. The positions we hold are voluntary positions with no payment, the only benefit being (in my case) considerable enjoyment in looking after not only our member's, but the legacy of those who went before us, and created the wealth they left in our hands to manage. I also reflect at times on the wonderful job the women who were part of our wonderful Women's Auxiliary did over many years.

I would like to congratulate our current President Greg Goodieson, who is certainly dedicated to the position, and is doing a great job in coming to terms with the obligations set by the RSL State Branch Constitution and directives. Greg is also the Treasurer of the Eastern Metropolitan District Council and along with Troy Nicoll our delegate.

On behalf of the sub-Branch executive committee and all members, I extend sincere condolences and expression of sympathy to the families and friends of those departed in 2024.

Hello members,

My annual report is here for your perusal.

2024 was a year of excitement and growth with the much-awaited opening of the Club and our

Sub-Branch office. This may have been late happening, but we are there now in modern premises. December had a couple of wild storms which led to the offices flooding, something which was not our wish list.

The growth came from Morgan Stanley and EthInvest, where we have \$5.5 million invested. The average return is 12% which is an incredible return and Patrick from Morgan Stanley is thinking that 2025 should also give good returns.

Donations for the year \$151k, the majority was distributed into the RSL NSW Veterans Support Fund.

Most properties are giving good returns but, Patonga is severely dragging the chain. It was raised at the December quarterly meeting with strong debate both for and against. A show of hands indicated most were in favour of selling the asset which is worth about \$2 million. Imagine an extra \$2 million at 12%!! More of this as we move into 2025.

Lisa, our wonderful office worker is happy with the new space and continues to do a marvellous job for us. President Greg is continuing to learn and is going ahead in leaps and bounds. Secretary Bill is as solid as ever and the rest of the committee have been hard working and diligent, I thank all of the committee for your support. I also thank you, the members for your contribution during 2024. Here's to a bigger and better 2025.

Planning is well underway to expand the sport and recreation program to incorporate a number of new activities in 2025 with lawn bowls starting in Feb as well as more coffee clubs, I would like to thank everyone that has attended our activities and we look forward to seeing more of you in 2025. If there is anything you would like to see or an event you would like the sub-Branch to participate in, please let us know. NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2024

This financial report is for Bondi Junction-Waverley RSL Sub-branch as an individual unincorporated entity domiciled in New South Wales, Australia. The financial statements were authorised for issue on the 14th of February 2024. The functional and presentation currency of the Company is Australian dollars and all values are rounded to the nearest dollar.

1 Basis of preparation

The financial report has been prepared on the basis that Bondi Junction-Waverley RSL Sub-branch is a non-reporting entity because there are no users dependent on a general-purpose financial report. The financial report is therefore a special purpose financial report that has been prepared in order to meet the requirements of the Australian Charities and Not-for-profits Commission Act 2012 and the significant accounting policies disclosed below which the Sub-Branch Committee have determined are appropriate to meet the needs of the members. Such accounting policies are consistent with those of previous periods unless stated otherwise.

The Sub-Branch is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards.

As the Sub-branch is not a reporting entity, it is not required to prepare financial statements in accordance with Accounting Standards. Applicable Accounting Standards and other mandatory reporting requirements have been adopted with the exception of the following:

AASB 139 Financial Instruments: Recognition and Measurement

2 Summary of significant accounting policies

2.1 Income tax

The Sub-branch is registered under the provisions of the Charitable Fundraising Act, 1991 and in accordance with section 50-5 of the Income Tax Assessment Act, 1997 is exempt from income tax.

2.2 Property, plant and equipment

Each class of property, plant and equipment is carried at cost or fair value as indicated less, where applicable, any accumulated depreciation and impairment losses.

2.3 Depreciation

The depreciable amount of all property, plant and equipment, including buildings is depreciated on a straight-line basis over the asset's useful life commencing from the time the asset is held ready for use.

Cash at bank is interest bearing at rates of between 0.01% and 0.25% p.a. (2024: 0.01% to 0.25%).

2.5 Revenue and other income

Interest received and recognised as received and as it accrues from day to day.

At balance date interest accruing but not yet credited is calculated and brought to account to reflect total earnings for the financial year.

All other revenue is brought to account as it is received.
